The Departmental Promotion Committee (Higher) Meeting held on 29.01.2021 at 2.30 PM in the Chamber of Chairman DPC (Higher) examined the proposal for preparing select list for promotion to the post of Joint Director and Principals in Government Polytechnic Colleges in the vacancies which arose during 2014, 2015, 2016, 2017, 2018 and 2019. In the light of the order dated 10.11.2017 of the Hon'ble Kerala Administrative Tribunal in OA (EKM) 257/2016 filed by



Sri Rajasekharan.V.M, Workshop Superintendent (Rtd), Government Polytechnic College, Kalamassery, the promotions of HOD Mechanical Engineering effected during 2014 and 2015 was set aside. The court also directed for effecting promotions as per 2010 AICTE Regulation.

2. In the subsequent order G.O (Rt) No: 883/2020/HEDN dated 29.06.2020 Government Ordered to reconsider and recast all the promotions granted on 2014 and 2015. Meanwhile the Honorable Supreme Court through its Judgment in the Civil Appeal of 16678 of 2020 dated 18.2.2020 has ordered that Ph.D is not mandatory for the post of Principal in Polytechnic College.

3. In the light of the above, DPC decided to prepare the Select List, up to 01.03.2019 in the case of Principal and up to 2020 in the case of Joint Director.

4. The Departmental Promotion Committee considered the selection of candidates for appointment to the post of Joint Director/Principal and consequent reversions, on the basis of the qualification stipulated for the post, as per AICTE Regulations 2010.

5. The Departmental Promotion Committee (Higher) (DPC) examined the seniority list as per G.O (P) No. 2/2021/H.Edn dated: 23.01.2021 and verified the Confidential Report(CR) of the incumbents included in the field of choice and decided to prepare the select list by including the following incumbents.

**Select List for Joint Director in the vacancies which arose during 2014, 2015, 2016, 2017, 2018, 2019 and 2020:**

4 vacancies of Joint Director are available for the period from 2014-2020. The DPC decided to include the following in the select list against each vacancies as detailed below.
